## Building Access Instructions

### Independence Ave Entrance - Hand Carried Items Only

This entrance will open at 7:30AM for entry/exit into the Rayburn Building. Once you clear security (think airport), you will walk up a set of stairs at which point you can walk left, right or straight. There will be NTSA signs to direct you.

For those of you needing an elevator, walk to the right and take the elevators up to Level 1; exit left off the elevators on level 1 and the Rayburn Foyer Room will be down the hall on the left.

If you walk straight you will see 2 sets of round staircases, you may walk up the stairs which will place you in front of the Rayburn Foyer.

### Capitol Ave Entrance 24 hour entrance- Hand Carried Items Only

If you need to arrive prior to 7:30 AM you may also use the Capitol Ave Entrance 24 hour entrance, although you will have to backtrack to the Rayburn through underground tunnels. Please allow extra time to get through security.

## Payment Information
